



**1976-1996 CJ-Wrangler Nylon Door Replacement handles  
Installation Instructions: (p/n: 11825.01)**



- (1) Unscrew and remove the two retainer covers holding the OE door handle in place. You will need a T25 Torx head bit or screwdriver.
- (2) Discard old parts as new kit is supplied with all new mounting hardware.
- (3) Take new retainer cover and place over grommet eyelet as shown in **(Fig.1)**. In some cases an extra amount of nylon webbing by protrude past the cover. Fold over if possible and stuff remainder into cover.

- (4) Place new handle with cover onto door panel and secure using new hardware supplied. The T25 Tork head bit or screwdriver will be used again **(Fig.2)**.
- (5) In some cases the nylon strap may need to be pushed back under the retainer cover prior to tightening. If needed this can be accomplished by using a flat head screwdriver as seen in **(Fig.3)**. When finished the cover plate and grab handle should look like **(Fig.4)**
